Bidders must submit the following documents in order to be considered for this bid:

- **Original and valid** tax clearance or a Printed copy of a tax clearance certificate accompanied by a pin for further verification.
- **Certified ID(s) copies** of company director(s) **not older than three months**
- **Certified** Proof of company registration **not older than three months**
- **Proof of payment** for tender document
- Company municipal rates, electricity or water account **not older than 3 Months**, proof of Residential lease or rental or sworn affidavit if the business operates at a place of residence.
- Completed and signed Municipal Bidding Document attached in the tender document
- Registered to South African Council for Planners (SACPLAN)
- Registered on Central Supplier Database

Evaluation will be done on the following two-stage process in terms of National Treasury Circular No: 53
Stage 1: Assessment of Functionality. Only service providers who achieve a minimum of 60% or 54 points of the total available points will qualify for stage two of the Evaluation process.

The points for stage one will be allocated as follows:

Stage2:

The 80/20 preferential point system will be applied, where 80 points will be allocated for price and 20 points for B-BBEE Status. Bidders must submit original or a certified B-BBEE Certificate issued by an Accounting Officer as contemplated in the CCA or a verification Agency accredited by SANAS or a Registered Auditor or Sworn affidavit to claim preference points .
