Documents will be opened in public.**Late Telegraphic, faxed, Emailed or posted tenders will not be accepted.** Bidders must attach the following **mandatory returnable documents** in order to be considered for this bid:

- Printed Copy of tax clearance certificate accompanied by a **pin** for further verification.
- **Certified ID(s) copies** of company director(s) (**Not older than 3 months**)
- **Certified** Copy of company registration (**Not older than 3 months**)
- **Proof of payment** for tender document
- Company municipal rates, electricity or water account **not older than 3 Months**, proof of Residential lease or rental or sworn affidavit accompanied by proof of residents if the business operates at a place of residence.
- Completed and signed Municipal Bidding Document attached in the tender document.
- Registered on Central Supplier database.

Evaluation will be done on the following two-stage process in terms of National Treasury Circular No: 53

Stage 1:

Assessment of functionality. Only service providers who achieve a minimum of 60% or 48 points of the total available points will qualify for stage two of the Evaluation process .The points for stage one will be allocated as follows:

Proven track record	30 points
Proof of Experience (CV and Qualification)	20 points
Methodology	20 points
Lead time	10 points
Financial Viability	10 points
Total	(90)

Stage 2:

The 80/20 preferential point system will be applied, where 80 points will be allocated for price and 20 points for B-BBEE Status. Bidders are encouraged to submit an original or certified copy of B-BBEE certificate issued by Verification Agency accredited by SANAS to be awarded BBBEE Points. In case of EMEs bidder may submit an original SWORN Affidavit signed by a commissioner of oaths to claim Preference Points.
