- **Certified** Proof of company registration not older than three months
- **Proof of payment** for tender document
- Company municipal rates, electricity or water account **not older than 3 Months**, proof of Residential lease or rental or sworn affidavit accompanied by proof of resident if the business operates at a place of residence.
- Completed and signed Municipal Bidding Document attached in the tender document.
- Listed on the Municipal Supplier database and or Central Supplier database.

Evaluation will be done on the following two-stage process in terms of National Treasury Circular No: 53

**Stage 1: Assessment of Functionality.** Only service providers who achieve a minimum of 60% or 48 points of the total available points will qualify for stage two of the Evaluation process.

The points for stage one will be allocated as follows:

**Stage2:**

The 80/20 preferential point system will be applied, where 80 points will be allocated for price and 20 points for B-BBEE Status. Bidders must submit a certified certificate issued by Verification Agency accredited by SANAS to be awarded BBEE points. In case of EMES may submit original sworn affidavit signed by commissioner of oath to claim preference point.
